Code of Conduct Complaint Against Nathan Colquhoun

Fact Statement

1. In a public post on both social media and his online public blog on April 18, 2022, Councillor Colquhoun has once again flagrantly and blatantly broken the Code of Conduct. He even publically acknowledged he was breaking the code of conduct in this public display of his flagrant disrespect of both the integrity commissioner process and the municipal act. Colquhoun's current behaviour was in contravention of Sections 11.1, 11.2, 11.4, 11.5, 12.2, and 19.17 of the Code of Conduct as further described below.

2. Colquhoun once again betrayed confidential information this time pertaining to a code of conduct complaint against him dated March 23, 2022. He published online in a blog and on social media (Facebook) the entire confidential code of conduct complaint and also your letter, Mr. Watson, in which you remind him that section 19.17 of the Code requires him to "preserve secrecy". You further state to him in this now public correspondence that "this letter is confidential and no information from this letter is to be shared with any other person or entity". This Councillor actually has the audacity to publish your letter instructing him that he cannot release it. For an elected official to have this lack of morals, integrity and honesty is almost incomprehensible. Please see attached Appendix A which is a copy of Colquhoun's Facebook post, his online public blog, the copy of your confidential letter dated April 12, 2022 and the first pages of the code complaint. Please note he published the entire code complaint but I have included the first pages only to prove the release. All of this confidential information has now been publically released by Councillor Colquhoun.

3. The following statement was also made publically by Colquhoun in his Facebook post and is in blatant contravention of section 12.2 of the Code of Conduct. In addition, it is contrary to Section 11 of the Code given he has once again revealed unproven, unsubstantiated, and unfounded closed meeting information from the in camera session of November 15, 2021. This is clearly in violation of not only the Code of Conduct but also, once again, the Municipal Act. This closed session claim is not only unsubstantiated but abusive, insulting and slanderous to Councillors Burrell and Dennis. The screenshot is attached as Appendix B. You will note when Colquhoun was asked to "prove it" by a member of the Public, he instead said, "Prove it's not true".

4. In summary, Colquhoun has once again deliberately and blatantly broken the Code of Conduct. He states publically in this current breach that "The irony is that I am not supposed to share complaints made against me so I am breaking the code of conduct again." He has zero respect for the rules of law and order and further states "I am also sharing this because of how ridiculous the use of the Integrity Commissioner mechanism is for our City." Colquhoun's appalling lack of regard for both his legal and moral responsibilities associated with his elected position is not only horrifying but also criminal. This unethical individual goes as far as admitting publically that he is breaking the Code as he does it, this is an absolute disgrace. This flagrant lawlessness is beyond comprehension and for the sake of our City needs to be stopped.



A few days ago, I was made aware that another Integrity Comissioner complaint was lodged against me. As always, in the interests of transparency, I am sharing what the complaint was against me. The irony is that I am not supposed to share complaints made against me, so I'm breaking the code of conduct again. I am also sharing this because of how ridiculous the use of the Integrity Comissioner mechanism is for our city. It has served to do nothing but politicize us and be weaponized to try to shame council members to the public. And as we have seen now by both Bradley and Dennis, they like to harness their power of the public to decry their innocense against an unfair process, and it has worked to elevate both of their platforms. In the complaint, they claim that the release of the information that I shared is a "betrayal of public office." I would disagree with this statement, and that I think it would be a betrayal of my position in public office not to share it. The public has a right to know who they elected and what they stand for, and I will not sit by and allow closed meetings to be how they can hide their true character.

So I'm here to admit my guilt right away. I am not innocent. I am guilty of sharing the KOJO letter and exposing Bill Dennis and Terry Burrell as being the councillors that were hostife and racist in both the diversity training session and the closed meeting after where I made a motion to release the KOJO letter to the public. In my opinion, I am not sharing anything that shouldn't be public. There is no harm to the city of Sarnia by telling the public who these councillors were and sharing the KOJO letter that KOJO had already publicly said was fine to share.

Statement of Facts

- It has been reported that Council attended a closed session meeting for the provision of EDI training on November 15, 2021.
- 2. December 13, 2021 in a closed session meeting Nathan Colquinous has said publically that he made a motion to release a letter received from KOIO (notitute public that motion did not pass this information was subsequently released to the public on February 22, 2022 when written about in the Sarnia Journal (see attachment Aa) and on February 24, 2022 by Nathan Colquinous do a jouring on his website with Nathan Colquinous com (see attachment Ab). Releasing this information is a breach of the City of Sarnia Code of Conduct section 11 aubsection 11.1, 11.2, 11.4, 11.5, 11.6 (k) and (m) as wall as a breach of the Municipal Act Section 239.
- 3. February 22, 2022 Nathan Colquinoun shared links to two Samia Journal articles on his publicly accessible facebook page with the commant "h's a bit of a puzzle, but if you read both of these articles you might be able to guess who our hostile councilor ht. LOL" he attached links to two Samia Journal articles stilled "Hostile councilors bring abrupt and to Samia Journal articles stilled "Hostile councilors bring abrupt and to Samia Salvestity and equity training" (see attachment Aa) and "Infighting, bitter attacks plaguing Samia council" (see attachment Ab). Nathan Colquinoun's comments are a breach of the City of Samia Code of Conduction Section 11 subsection 11.5 and it is clear from the

content of the news articles that confidential information had been shared with the madia.

- 4. Further to the February 22, 2022 posting on Nathan Colquboun's facebook page Nathan comments back and forth with members of the public where he continues to disparage a council member and reveal alleged in camera information when he says.
